This paper examines the existence of political cycles in the awarding of World Bank procurement contracts around elections. We consider elections in the home country of firms winning these contracts, whether the firms come from the aid recipient country (*i.e.* domestic firms) or from other supplier countries (*i.e.* foreign firms). Our findings indicate that domestic firms are more likely to secure larger contracts around elections in their home country, especially when corporate donations to candidates are allowed. Additionally, our results reveal an increase in contract sizes awarded to foreign firms before elections in their home country. This cross-border political cycle appears to be driven by strong aid partnerships and historical colonial ties between the supplier and recipient countries.

Do Roads Lead to Exports? Chinese Transport Infrastructure Projects in Developing Countries Work in progress

In recent decades, China has become a crucial provider of transport infrastructure in developing countries. This paper investigates the impact of Chinese-funded transport infrastructure on firm-level development, focusing on its influence on firms' likelihood to export. To explore these effects, I matched firm-level data from the World Bank Enterprise Survey with geolocated Chinese-funded transport projects implemented between 2000 and 2019. Employing an instrumental variable strategy, I exploit the interaction between a region's probability of receiving transport projects and labor unrest in China as a source of exogenous variation. The analysis reveals no significant overall effect of Chinese transport infrastructure on firms' export probabilities. However, heterogeneity analyses suggest that firms in low-population-density regions benefit more from these projects.

Borders, Repression, and Electoral Persistence: The Legacy of 1851 Work in progress Runner-up for the Wicksell Prize during the EPCS conference 2023 in Hannover.

This paper investigates how diverging historical trajectories and exposure to political repression in the 19th century influenced long-term electoral outcomes. Leveraging the natural experiment created by the 1815-1860 border separating France from the Duchy of Savoy and the County of Nice, I employ a spatial discontinuity design to estimate the political legacy of these distinct paths, characterized by different exposure to the 1851 political repression against Republicans. The results indicate that communes remaining in France during this period have a persistent preference for left-wing candidates, which is driven by limited cross-border population mixing during higher education and at work. Archival data on arrest reports reveal that the 1851 political repression increased abstention rates. Further analysis suggests the repressions long-term effects stem from its impact on local political demand and supply, as well as a contraction in the Republican activist network.
