Social ties and first child's birth: a motherhood network penalty

In most developed economies, child-related inequalities have become the main cause of gender inequalities in the labour market. This paper examines how fathers' and mothers' social networks evolve after the birth of the first child, and how this affects mothers' labour market reintegration. Using longitudinal data from the United Kingdom, I document a significant decline in the share of employed friends among mothers, whereas fathers' networks remain unaffected. This is what I refer to as the *motherhood network penalty*. Because of well-documented network effects on job search outcomes, I then adapt a model of labour market transitions with networks to quantify how the lower share of employed friends among mothers contributes to their reduced labour market reintegration. Counterfactual simulations show that, in the absence of the *motherhood network penalty*, the decline in mothers' re-employment post-birth would be substantially lower. These findings highlight the potential value of policies aimed at counteracting mothers' loss of valuable contacts to support their labour market re-employment postbirth.
